SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Burns: Flush with water immediately. While flushing, remove clothes which do not adhere to affected area. Call an ambulance. Continue flushing during transport to hospital.

Inhalation: Move injured person into fresh air and keep person calm under observation. If uncomfortable: Seek hospital and bring these instructions.

Symptoms/effects: Dizziness. Headache. Coughing. Eye irritation. Dermatitis possible through repeated contact. Ingestion: Nausea, vomiting. Aspiration hazard. Be aware that symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure.
