## SECTION 4: FIRST AID MEASURES

### 4.1. Description of first aid measures

**Burns:** Flush with water immediately. While flushing, remove clothes which do not adhere to affected area. Call an ambulance. Continue flushing during transport to hospital.

**Inhalation:** Move injured person into fresh air and keep person calm under observation. If uncomfortable: Seek hospital and bring along these instructions.

**Ingestion:** Not likely, due to the form of the product. In case of ingestion: Aspiration hazard. Immediately rinse mouth and drink 1-2 glasses of water. DO NOT induce vomiting. Get medical attention immediately. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.

### 4.2. Most important symptoms and effects, both acute and delayed

**Symptoms/effects:** Dizziness. Headache. Coughing. Eye irritation. Dermatitis possible through repeated contact. Ingestion: Nausea, vomiting. Aspiration hazard. Be aware that symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure.

### **5.1. Extinguishing media**
